1030 – 1100 KEYNOTE SPEAKER

Mrs Soraya Sáenz de Santamaría, Vice President of the Spanish Government and Minister for the Presidency (2011-2018)

Mrs Sáenz de Santamaría combines an impressive experience in both the public and private sectors. Qualified as a lawyer for the government (1988), she was the Vice President of the Spanish Government and Minister for the Presidency (2011-2018), minister of territorial administrations (2016-2018) and spoke person for the Government (2011-2016). Mrs. Sáenz de Santamaría chaired the inter-ministries commission for Brexit (2016-2018). She is a member of the State Council since 2018, a board member at Moeve and an external counsel to Cuatrecasas law firm.

Mrs Saenz de Santamaria shall provide her view on the current geo-political environment, the Spanish business context, the importance of the relationship with France and, more broadly, with the European Union. She will address the different roles played by Governments, public and private stakeholders in promoting such relationships, and the relevance of a robust legal framework.

The intervention will be followed by a Q&A with the audience moderated by Almudena Arpón de Mendívil.

A conversation with Mr Miquel Roca Junyent

At times of convulsion, we must recall the relevance of dialogue and of commitment to consensus. Mr Roca Junyent is such a great example in that field. He is a lifeful page of Spain's transition to democracy, a historic moment marked by political leaders with a strong belief in the need of reaching agreements. Mr Roca Junyent is one of the seven fathers of the Spanish Constitution approved in 1978 which allowed Spain to walk into the democratic path. Mr Roca Junyent also authored the draft Catalonian statute of autonomy.

Born in Bordeaux, an active lawyer with now more than 50 years of experience, founding partner and honorary president of the law-firm RocaJunyent, member of the board of directors of companies such as Abertis, Banco Sabadell and Aigües de Barcelona, amongst other, Mr Miquel Roca will share with us his views regarding the relevance of the European Union and the increasingly important roles that France and Spain should play within the same.

Mr Roca Junyent shall also reflect on meaningful ways in which the legal profession should contribute to achieving that goal.

Mr Roca Junyent's intervention shall develop as a conversation with Almudena Arpón de Mendívil, followed by a Q&A with the audience.

Investments scenario for Spanish/French transactions: might the regulatory burden be too high?

There seems to be a slight reduction in the number of significant cross border deals between France and Spain in the last year. On the other hand, the French Spanish Cooperation Treaty signed in January 2023, has not yet been ratified. This panel will look at how cross border investments between the two countries have developed with a focus on the impact on transactions of sectorial regulatory approvals added up to the general antitrust and FDI controls. It shall address the best practices to make the deal go through.

The increasing role of foreign (sovereign) funds in M&A transactions: a comparative look at Spain and France

Infrastructure, energy, utilities and real estate investment funds are significantly increasing their investments in Spanish and French corporates. These funds channel private savings – eg, the Canadian pension funds- or public revenue – eg, the Norwegian Government Pension Fund Global, Norges and the various Gulf state funds.

We shall address what the reaction has been towards investments by these funds both by the business community as well as on the part of authorities and regulators, in an effort to identify similarities or differences for purposes of transaction structuring and implementation with the involvement of such funds.

Defence as a European priority: opportunities and challenges of the EU ReArm Europe Readiness 2030 Plan

The French and Spanish defence industries represent a significant share of the European and global markets, key players and a big number of midcaps supplying weapons, dual use equipment and advanced technology systems and components. The opportunities placed by the ReArm Europe Readiness 2030 plan, as outlined in the March 2025 White Paper for European Defence, will impact those industries and will require massive investment from both the public and private sectors. It will also need simplification and harmonisation of regulations, among others: the award of works, supplies and services by contracting authorities, intra EU transfers of defence products, granting of licenses, and employment frameworks. Such investments should also be simplified in the fields of merger control, antitrust and State aid rules.

We will open a debate about the different approaches in the French and Spanish jurisdictions to this evolving framework and the opportunities for cooperation between local defence industries
