Call for Applicants - European Lawyers Programme 2016 - Edinburgh

The European Lawyers' Association (**ELA**)¹ is calling for applicants to apply for the European Lawyers'Programme 2016 (hereafter **ELP** or **Programme**) consisting of a three months' legal placement including a 2 week induction course in Scots law in Edinburgh, Scotland commencing on **29 March 2016**. The Programme is an (adapted) continuation of the British Council's 'European Young Lawyers Scheme' which ran successfully for over 30 years.

The course will consist of a 7-day introductory course on Scots law covering a wide range of legal subjects, followed by an 11 week practical placement with Scottish Advocates, Queen's Counsel and members of the Scottish judiciary (Judges of the Court of Session/High Court).

The ELA is looking for lawyers who are currently practising either in-house or in private practice and have been for at least two years and who are interested in gaining a practical legal experience in Scotland. The chosen candidates would be expected to take approximatively 3 months leave from their current employment in order to attend the Programme in Edinburgh. The Programme enjoys the support and participation of the **Faculty of Advocates**, i.e. the Bar in Scotland, who (together with the ELA) will provide administrative& logistical support and organise the Programme placements with the Advocates and Queen's Counsel. **Vialegis**² is the Programme's main financial sponsor and their support will enable the ELA to cover certainexpenses³. Twelve lawyers from different European countries will be selected to attend the Programme. Should you wish to apply for a place on the Programme, please submit an application form, your CV and a motivation letter to **internacional@icam.es** by no later than **20 October 2015**.

If your application is admitted, the selection process will take place in **Madrid** during the week commencing **29 October 2015** (you will be notified of the exact date/time). The selection process will include an interview which will be conducted in English.
