
“STAGE INTERNATIONAL” AND “INTERNATIONAL PROGRAM”

PROGRAMS: « STAGE INTERNATIONAL » and « INTERNATIONAL PROGRAM »

Since 1991, the Paris Bar organises a unique training program targeting young French speaking lawyers. The "*Stage International*" brings together in Paris, during two months of theoretical and practical training, young French speaking lawyers, selected by the Paris Bar from among applications received each year from all over the world. Since 2015, the Paris Bar has been organising a second version of the program for English-speaking lawyers, the "*International Program*". These programs are organised in cooperation with the foreign bar associations and supported by some French Embassies abroad.

WHEN ?

In 2019,

- The *Stage international* will be held from Monday October 7th to Friday November 29th (8 weeks)
- The *International Program* will be held from Monday May 6th to Friday June 28th (8 weeks)

WHY?

The « *Stage International* » and the « *International program* » are first and foremost an encounter between lawyers in an international and fraternal atmosphere; they are an opportunity to compare practices and establish lasting bonds of friendship and business.

Objectives :

- Strengthen relations between the bars who can recommend participants;
- Create a network through the lawyers and firms who participated in the program;
- Promote the exchange of legal experience and knowledge as well as the practice of comparative law.

FOR WHO?

This program is intended for young lawyers (up to 40 years), French speaking or English speaking, of any nationality willing to discover the practice of French law through quality education and a discovery of professional practice in Parisian volunteers law firms. These lawyers must have civil liability insurance, have a good knowledge of French for the "*Stage International*" or English for the "*International Program*".

WHAT?

Theoretical training: during the first month, the participants benefit from a training at the "*Ecole de Formation du Barreau*" to enable them to apprehend in a practical way the French legal system and its procedures in civil, criminal and commercial matters. They discover the daily reality of the *Palais de Justice* by going regularly to hearings, visit the major French institutions and discover the European Law.

Practical training: during the second month, they have the opportunity to be at the heart of the Parisian legal life alongside Parisian volunteers lawyers.

APPLICATION FORM:

Applications should include the following documents:

- For the "*Stage International*": a curriculum vitae in French, a motivation letter in French, a photograph, a copy of the passport and a certificate of registration at the bar in 2019 (deadline for receipt of applications: June 3rd).
- For the "*International Program*": a curriculum vitae in English, a letter of motivation in English, a photograph, a copy of the passport and a certificate of registration at the bar in 2019 (deadline for receipt of applications: April 12th ideally).
